

THE TINCUP BACKCOUNTRY ADVENTURE CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Void outside the US, in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, and wherever else prohibited by law.

TIMING: The TINCUP Backcountry Adventure Contest (the “Contest”) is presented by Proximo Spirits, Inc. (the “Sponsor”) and administered by US Sweepstakes & Fulfillment Co. (the “Administrator”). Contest begins at 12:00:01 AM Eastern Time (“ET”) on Friday, May 31, 2019 and ends at 11:59:59 PM ET on Thursday, July 11, 2019 (the “Promotion Period”).

By participating in the Contest, each participant (“Entrant”) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor and Administrator, which shall be final and binding in all respects.

ELIGIBILITY: The Contest is open to legal residents of the 48 contiguous United States, including the District of Columbia, who are age 21 or older at the time of entry. Void in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Sponsor, Administrator and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Contest is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER THE CONTEST: During the Promotion Period, Entrant may submit a brief description and photo featuring what the mountain means to him/her (the "Photo"). Entries must consist of friendship, bonding and physical challenges in the great outdoors through one of the two (2) methods below:

Method #1: Instagram Entry. Log in to your Instagram account, follow @tincupwhiskey on Instagram, and upload and share your Photo to your public Instagram account, including the hashtags #YourMountainAwaits and #Contest and @tincupwhiskey in the photo caption (the "Instagram Entry"). Entrant's Instagram settings must be public. Instagram Entries uploaded from "private" Instagram accounts will not be eligible. Instagram Entrants must follow and continue to follow @tincupwhiskey through at least August 1, 2019 in order to be notified in the event he/she is a potential winner. Method #2: Twitter Entry: Log in to your Twitter account, follow @tincupwhiskey on Twitter at <https://twitter.com/tincupwhiskey>, post a Tweet that includes @tincupwhiskey and the hashtags #YourMountainAwaits and #Contest to receive one (1) entry into the Contest (the "Twitter Entry"). Message and data rates may apply. If a Tweet is more than one post in length it will be considered as one (1) entry into the Contest with the first post considered the Twitter Entry. By using the hashtags, participant indicates his/her agreement to these Official Rules. Entrant's Twitter settings must be public. Tweets from private Twitter accounts will not be eligible. Twitter Entry must be posted directly from a participant's Twitter account. The decisions of the Sponsor are final and binding on all matters relating to determine eligibility of Tweets. Entrants must follow and continue to follow @tincupwhiskey through at least August 1, 2019 in order to be notified in the event he/she is a potential winner. By submitting a Twitter Entry, entrants agree to [Twitter's Terms of Service](#). **This Contest is in no way sponsored, endorsed or administered by, or associated with, Twitter, Inc.**

Instagram Entry and Twitter Entry collectively referred to herein as "Entry" or "Entries".

Sponsor may not receive Entries from users with "protected" updates or profiles that are not public (i.e. user has set the account so that only people the user has approved can view updates). Entries not received by the Sponsor will not be entered into the Contest. Multiple participants are not permitted to share the same email address or Instagram/Twitter account. Although subsequent attempts to submit an Entry on a given day may be received, only the first complete Entry received from a particular Entrant will be eligible; subsequent attempts by the same person to Enter, including entries submitted with an alternate Instagram or Twitter account, or identity will be disqualified. There is a limit of one (1) Entry per person per Instagram handle and Twitter handle per day. Each Entry must include an original Photo and description. Entries submitted with a Photo and description that has already been submitted will be disqualified.

For the avoidance of doubt, uploading a Photo to Instagram or Twitter alone will NOT result in an entry into the Contest. Once an Entry is submitted it cannot be modified by an Entrant. Sponsor is not responsible for lost, late, incomplete, illegible, garbled, inaccurate, invalid, misdirected, undelivered, or delayed Entries. No altered or incomplete submissions will be accepted.

Entrants are subject to all notices posted online, including but not limited to the Sponsor's Privacy Policy.

ENTRY REQUIREMENTS & CONDITIONS: All Entries must comply with the following minimum guidelines to be eligible:

- Photo must show what the mountain means to him/her.
- Entrant should be the primary subject of the Photo. No other individuals may appear in the Photo, without express permission.
- Photos submitted via Instagram or Twitter must include the hashtags **#YourMountainAwaits** and **#Contest** and **@tincupwhiskey**.
- Photos must conform to the format and size requirements and limitations of Instagram or Twitter.
- Entry and Photo cannot contain content that is irrelevant to the purpose of the Contest.
- Once a Photo has been submitted, it cannot be modified or deleted by Entrant.
- Each submitted Photo must be original, on which no image editing software has been used, and cannot have been submitted previously in a promotion of any kind or won any previous awards.
- No duplicate Photos, or substantially similar Photos, as determined by the Sponsor in its sole discretion, may be submitted.
- By submitting a Photo taken by a third party, Entrant warrants and represents that he/she has secured all rights and clearances to the Photo from the photographer.
- Entry and Photo cannot be profane, pornographic, sexually explicit or suggestive or contain nudity.
- Entry and Photo cannot be violent or promote firearms/weapons.
- Entry and Photo cannot include the consumption of alcohol or promote illegal drugs or tobacco.
- Entry and Photo cannot defame, misrepresent or contain disparaging remarks about people, brands, products or companies.
- Entry and Photo cannot contain content that defaces or depicts any person, brand, product or company in a negative or inappropriate manner.
- Entry and Photo cannot be obscene or offensive, endorse any form of hate or hate group or be derogatory to any ethnic, racial, gender, religious, professional or age group.
- Entry and Photo cannot reference or contain materials embodying copyrighted images, names, likenesses or other indicia identifying any brand, products, company or person (aside from entrant), living or dead, without permission.
- Entry and Photo cannot communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor, Instagram, and Twitter wish to associate.
- Entry and Photo cannot depict illegal activity and cannot itself be in violation of any law.

- Entry and Photo cannot in any way reference persons or organizations without written permission from any person or organization whose name or likeness is used.
- Entry and Photo may not include images of a known celebrity, famous person, public figure or any image which violates the right of privacy or publicity of any person.

By submitting an Entry, Entrant warrants and represents that: (a) Entry and Photo do not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other legal or moral rights of any person or entity; (b) Entrant has obtained written permission from any person who may appear in the Photo; (c) Entrant owns all rights to the Photo, including without limitation, copyrights, and has received prior written permission from a third party if any Photo was photographed by someone other than the Entrant him/herself; and (d) Entrant will indemnify and hold harmless the Sponsor, Administrator and related entities, agents and assigns from any claims and damages (including reasonable attorneys' fees) arising from or relating to the breach or alleged breach of your representations and warranties herein, the Entry, or Entrant's conduct in creating the Entry, the acceptance or use of any prize or otherwise in connection with this Contest.

JUDGING & WINNER DETERMINATION: The Judging & Winner Determination Period will begin on Friday, May 31, 2019 and be completed on Monday, July 15, 2019. All eligible Entries received during the Promotion Period will be judged by a panel appointed by the Sponsor, who shall use the criteria set forth below:

- A. Unique and inspirational description of experience in Photo
 - The degree to which the Entry passionately describes a love for the outdoors and bonding/friendship.
 - Weight: (50%)
- B. Creativity / Originality
 - The degree to which Sponsor's theme 'your mountain awaits' is displayed in the Photo and description
 - Weight: (25%)
- C. Connection to Contest Theme
 - Connection to the Sponsor's theme of 'your mountain awaits'
 - Weight: (25%)

The five (5) Entries that receive the highest total score based on the judging criteria will each be deemed a potential winner. In the unlikely event of a tie, the tied Entry with the highest score in Criterion A, Unique and inspirational description, will be deemed the potential winner. If additional tie breakers are needed, the tie-breaking mechanism above will be used; however, instead of the highest score in Criterion A determining the potential winner from among the tied entries, the highest scores in each of Criteria B through C, in sequence (to the extent needed) will determine the potential winner. In the event additional

tiebreakers are needed, all tied Entries will be judged by a separate panel of judges using the judging criteria above.

WINNER NOTIFICATION & ACCEPTANCE REQUIREMENTS: Potential winners will be notified on/around Wednesday, July 17, 2019 via a private message to his/her Instagram or Twitter account (the "Initial Notification"), and he/she must respond as instructed to the private message from Sponsor. To begin the prize claim process, a potential winner must respond as instructed to the Initial Notification with his/her full name, email address, and date of birth within 48 hours of the Initial Notification. Any potential prize winner who does not reply to the Initial Notification with the required information and within the specified time period will be disqualified and an alternate winner may be notified.
